**ORDER APPROVING COMPLIANCE TARIFF SHEET**

Issue Date: July 26, 2024

Effective Date: August 18, 2024

On July 18, 2024, the Commission issued an *Order Granting Certificate of Convenience and Necessity* (Order) in this matter, effective August 17, 2024. The Order granted Spire Missouri Inc. d/b/a Spire a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Newton County, Missouri, as a further expansion of its existing certificated area.

The Commission granted the CCN subject to certain conditions, including that Spire file an updated tariff sheet incorporating the additional certificated area granted by the CCN.

On July 19, 2024, Spire filed a tariff sheet purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JG-2025-0009 and had a proposed effective date of August 18, 2024.

At the Commission’s request, on July 26, 2024, the Staff of the Commission reviewed Spire’s tariff sheet and filed its recommendation that the Commission approve the tariff sheet or allow it to go into effect by operation of law. Upon reviewing the

pleadings, the Commission finds Spire’s proposed tariff sheet complies with the Commission’s Order and will approve it. To enable the tariff sheet to become effective on the date requested by Spire, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheet filed on July 19, 2024, and assigned Tracking No. JG-2025-0009 is approved to become effective August 18, 2024. The approved tariff sheet is as follows:
