**ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR
INTERVENTION APPLICATIONS AND STAFF'S RECOMMENDATION**

On July 26, 2024, Spire Missouri Inc. (Spire Missouri) applied for an accounting authority order relating to certain of its interest rate hedging positions. Spire Missouri requested waiver of the Commission's 60-day notice requirement under 20 CSR 4240-4.017. Spire Missouri has also requested expedited treatment – specifically, that the Commission issue an order with an effective date no later than September 30, 2024.

The Commission will direct notice and set a time for interventions, responses to the application, and a Staff recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's data center shall send a copy of this order to the parties in File No. GR-2022-0179.

2. Applications for intervention shall be filed no later than August 13, 2024.

3. No later than August 27, 2024, the Staff of the Commission shall file either a recommendation or a statement indicating when it expects to file a recommendation.

4. Any response by any other party to Spire Missouri's application shall be made no later than August 27, 2024.
