5	Q: Please tell the Commission your name.
6	A: Corey Malone.
7	Q: And what is your occupation?
8	A: I am the owner and operator of Air Comfort Service, Inc., a Missouri corporation in
9	good standing. The company sells and services heating, ventilation, and air conditioning
10	equipment in the St. Louis metropolitan area.
11	Q: How did you become the owner/operator?
12	A: The company was founded in 1969 by my father-in-law, Gary "Doc" Jones. Upon his
13	retirement I became the president of the company.
14	Q: Could you tell the Commissioners about the company?
15	A: The company has two locations and currently employs seventy individuals, all of
16	whom are citizens and residents of the St. Louis metropolitan area. The company owns
17	fifty vehicles for use in its operations. The company pays property taxes on its buildings
18	and vehicles, pays and collects sales taxes as required by law, and pays employee and
19	income taxes to the state and federal governments.
20	Q: What is your involvement with the Missouri Coalition for Fair Competition
21	(MCFFC)?
22	A: I have been the president of the MCFFC for 15 years.

- 1 Q: What is the MCFFC?
- 2 A: It is a political action committee that represents the concerns of its members who are
- 3 individuals and businesses in the heating, ventilation, and air conditioning (HVAC)
- 4 industry.
- 5 Q: Are you familiar with the "Fair Competition Law," at §§ 386.754-.764 RSMo?
- 6 A: Yes. The MCFFC was instrumental in the passage of the "Fair Competition Law" in
- 7 1998, and its 2003 amendments, codified at §§ 386.754-.764 RSMo. The Fair
- 8 Competition Law states that a utility may not engage in HVAC services, using subsidized
- 9 dollars to compete with small businesses.
- 10 Q: Have you previously been involved in actions like this before?
- 11 A: Yes. This is not the first conflict between the parties. In 1999 the MCFFC filed a
- 12 complaint against respondent, then known as Ameren UE, for violating what was then
- known as the HVAC Act, after it engaged in advertising for an appliance repair plan.
- Pursuant to the parties' agreement, the PSC determined that respondent had violated the
- law and that it would stop and not repeat the offending conduct. MCFFC v Ameren US,
- 16 8 Mo. P.S.C.3d 234 (1999) (available at:
- 17 <u>https://psc.mo.gov/CMSInternetData/ON/Reports/PSC%20Reports%20Vol%2008%20M</u>
- 18 PSC%203d%20Dec%201,%201998%20-%20Jan%2031,%202000.pdf). And there have
- been other actions over the years against other utilities.
- 20 Q: When did you learn of the facts that led to the present complaint.
- A: I was first told that Ameren, Missouri, was engaging in the conduct alleged in ¶¶ 7, 8,
- 9, 10 and 11 of the Complaint of this case in 2019.

- 1 Q: What action did you take?
- 2 A: At my request, on November 21, 2019, MCFFC staff called Ameren employee Tina
- 3 Shannon.
- 4 Q: What was the MCFFC told?
- 5 A: On November 27, 2019, Ms. Shannon suggested that MCFFC members could apply to
- 6 participate in the program at https://www.ameren.com/company/business-
- 7 partners/suppliers.
- 8 Q: Did that solve the problem?
- 9 A: No.
- 10 Q: What did you do?
- 11 A: On December 2, 2019, MCFFC staff again called Ameren employee Tina Shannon.
- Ms. Shannon promised to look into the situation and respond.
- 13 Q: Did that produce a response?
- A: On December 11, 2019, I received the following e-mail, from an individual who
- identified herself as Nicole Sage, "the Ameren Missouri Community Savers Program
- Manager." She promised that she had my information and would include his company in
- the contractor procurement process in the future.
- 18 Q: Is Exhibit 1 a copy of that e-mail?
- 19 A: Yes.
- 20 Q: Did you have additional correspondence with Ms. Sage?
- 21 A: Yes. On December 12, 2019, I requested additional information regarding the
- program. Ms. Sage replied that all public information was on their web site.

- 1 Q: Is exhibit 2 a copy of her reply?
- 2 A. Yes.
- 3 Q: Did you visit the website?
- 4 A: Yes.
- 5 Q: What did you see?
- 6 A: Notably, that web site identified a single contractor: Anton's Air Conditioning and
- 7 Heating.
- 8 Q: Is Exhibit 3 a printed copy of what you saw?
- 9 A: Yes.
- 10 Q: What other contact did you have with Ameren related to this issue?
- 11 A: On March 3, 2020, MCFFC staff again called Ms. Shannon of Ameren. She advised
- that the references to Anton's Air Conditioning and Heating had been removed from the
- web site, and that Ameren would like to meet with MCFFC members and discuss
- 14 developing a program together.
- 15 Q: Did that conclude the matter?
- A: No. In 2022, I received an e-mail from a member of the MCFFC, Allen Eaker, who
- owns and operates a company that competes with mine, Lakebrink Heating and Air
- 18 Conditioning, which has as an attachment an estimate for HVAC services captioned,
- 19 "Ameren Missouri Pay As You Save Plan."
- 20 Q: Is Exhibit 4 that estimate?
- 21 A: Yes.
- O: What is notable about the estimate?

- 1 A: The estimate, which is on Ameren Missouri letterhead, states that the quote is
- 2 provided by Anton's Air Conditioning and Heating, another small business in the St.
- 3 Louis metropolitan area that provides HVAC services. At the time Anton's was owned
- 4 and operated by Craig Denton, with whom I am personally acquainted.
- 5 Q: What did you do in response?
- 6 A: I investigated the circumstances by visiting Ameren Missouri's website where I found
- 7 a page that posed the question, "How can I identify the Ameren Missouri energy
- 8 advisor?" The answer was, "Your home energy advisor will be wearing an Ameren
- 9 Missouri shirt and an Ameren Missouri picture ID badge. They will be driving an
- Anton's branded truck. Anton's Air Conditioning and Heating is a program approved
- 11 contractor."
- 12 Q: Is Exhibit 5 a copy of what you found?
- 13 A: Yes.
- 14 Q: Is Anton's still a local business?
- A: During the pendency of this proceeding, I discovered that Anton's Air Conditioning
- and Heating became the property of Anton's Acquisition Company, LLC, a Delaware
- 17 Corporation whose principal office is in Dallas, Texas.
- Q: Is Exhibit 6 a copy of the Fictitious Name Registration Statement?
- 19 Q: Was your company ever invited to participate in the program?
- 20 A: No.
- Q. Since filing the complaint in this case, have you heard from Ameren about the
- 22 program?

- 1 A: Yes. I received information that Ameren Missouri was hosting an open invitation
- 2 meeting regarding the Pay As You Save program on September 21, 2023.
- 3 Q. Did you attend?
- 4 A. Yes.
- 5 Q: What did you learn?
- 6 A: During the meeting, at Ameren's St. Louis headquarters, conducted by a third party,
- 7 EEtility, its Chief Executive Officer, Tammy Agard, told me and the other attendees that
- 8 if we referred a customer to their program preferred providers would perform the work.
- 9 Q: Were you told that the meeting was being recorded?
- 10 A: Yes.
- 11 Q: Did you ask for a copy of the recording?
- 12 A: Yes. During the meeting, EEtility's Chief Building Science Officer, Johnnie LaCaze,
- told me that he would provide me with a copy of the recording of the meeting. During
- 14 follow-up phone calls, LaCaze variously told me that the recording could not be released
- because it violated Ameren Missouri's security policies, but eventually agreed to send me
- a link to the recording. The link was restricted so that I could not save it and expired
- after 30 days. The recording on the link did not include Agard's statement about
- 18 preferred providers.
- 19 Q: Was the meeting productive?
- 20 A: Subsequent to the meeting the Pay as You Save web site added four contractors to its
- 21 list of contractors: Energy Stars, Superior Heating and Cooling, HB Mechanical

- 1 Contractor LLC, and Vitt Heating and Air. I do not know how these "approved"
- 2 contractors were selected.
- 3 Q: Did you save that?
- 4 A: Exhibit 7 is photograph of the list as of December 29, 2023.
- 5 Q: Did you undertake any further investigation of the facts of this case?
- 6 A: During the pendency of this proceeding, I visited the Anton's Heating and Air
- 7 Conditioning website on November 27, 2023, and found photographs of Anton's Heating
- 8 and Air Conditioning's building, vehicles and staff including at least three individuals
- 9 wearing what are clearly Ameren Missouri shirts.
- 10 Q: Are those photographs marked Exhibits 8A and 8B?
- 11 A: Yes.
- 12 Q: Does this conclude your direct testimony?
- 13 A: Yes.




