**ORDER SETTING EVIDENTIARY HEARING**

On July 8, 2024, Nancy Hurt requested the evidentiary hearing set for July 11-12, 2024, be continued to a future date. The Commission cancelled the hearing and directed the parties to submit their availability for an evidentiary hearing the week of August 19-23, 2024. Accordingly, the Commission will set an evidentiary hearing date for this complaint based upon party availability.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing is scheduled for August 20-21, 2024, beginning at 9:00 a.m. The hearing will be held virtually by telephone and videoconference via WebEx. 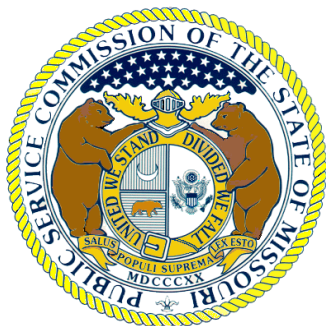
