**ORDER APPROVING TARIFF IN  
COMPLIANCE WITH COMMISSION ORDER**

Issue Date: January 8, 2019

Effective Date: January 20, 2019

On December 5, 2018, the Commission issued an order approving the stipulation and agreement of the parties that resolved the issues in this matter. The approved stipulation and agreement required Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) to file tariff sheets similar to the exemplar tariff sheets attached to the stipulation and agreement. On December 21, 2018, Ameren Missouri filed tariff sheets (Tariff No. YE-2019-0133) purporting to comply with the stipulation and agreement and the Commission's order. On January 4, 2019, Ameren Missouri substituted one tariff sheet to correct an error. The tariff sheets have a January 20, 2019 effective date.

The Commission ordered its Staff to file a recommendation regarding Ameren Missouri's tariff by January 7, 2019. The Commission also directed any other party wishing to respond to the tariff do so by January 7, 2019. Staff filed its recommendation on January 7, 2019, stating that it examined the tariff sheets, as substituted, and found them to be identical to the exemplar tariff sheets that were filed as an appendix to the approved stipulation and agreement with one exception. Staff noted in its recommendation that on Original Sheet No. 242, Ameren Missouri added the phrase

“(excluding Low-Income Efficiency Housing grants)” to the final sentence of the Program Description section. Staff stated that this change is consistent with the Company’s 2019-21 MEEIA Energy Efficiency Plan and recommended that the tariff sheets, as substituted, be approved. No other responses were received.

After reviewing the tariffs and the Staff recommendation, the Commission concludes that Ameren Missouri’s tariff sheets, as substituted, comply with the approved stipulation and agreement and the Commission’s order and will approve them.

**THE COMMISSION ORDERS THAT:**

1. Tariff sheets, bearing Tariff No. YE-2019-0133, filed by Union Electric Company d/b/a Ameren Missouri on December 21, 2018, and substituted on January 4, 2019, are approved to become effective on January 20, 2019.
2. This order shall become effective on January 20, 2019.

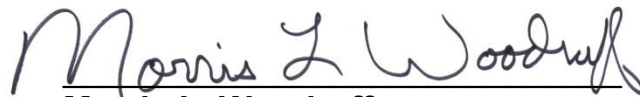
