## ORDER APPROVING TARIFF SHEETS

Issue Date: December 6, 2021

Effective Date: December 19, 2021

On October 13, 2021, Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission (Staff), and the Office of the Public Counsel filed a non-unanimous stipulation and agreement regarding the implementation of certain Missouri Energy Efficiency and Investment Act (MEEIA) programs through Plan Year 2023. Contemporaneously with that agreement, Ameren Missouri filed a revised tariff sheet to implement the part of the agreement related to decreasing the interest rate in the PAYS<sup>®</sup> program. On October 27, the Commission approved the agreement and the proposed tariff sheet to become effective on November 12, 2021. On November 19, 2021, Ameren Missouri filed additional tariff sheets (Tracking No. YE-2022-0154) to implement the remaining terms of the agreement. Those tariff sheets bear an effective date of December 19, 2021.

The Commission directed Staff to provide a recommendation regarding the tariff sheets and set a date for responses and objections to the tariff sheets. On December 2, 2021, Staff filed a recommendation to approve the tariff sheets. Based on Staff's recommendation, the Commission determines the tariff sheets comply with the

agreement and should be approved effective December 19, 2021. So that the tariff sheets may become effective as proposed, this order will become effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets, Tariff No. YE-2022-0154, filed on November 19, 2021, are approved to become effective on December 19, 2021.
2. This order shall be effective on December 19, 2021.
