ORDER DIRECTING A STAFF TARIFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On August 1, 2024, The Empire District Electric Company d/b/a Liberty filed a tariff sheet to update the Renewable Energy Purchase Program rate. Liberty's tariff sheet bears an effective date of September 1, 2024. The Commission will direct its Staff to examine the tariff sheet and file a recommendation as to whether it should be approved. The Commission will also set a deadline for any responses to Liberty's tariff sheet.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Liberty's tariff sheet no later than August 15, 2024.
2. Any other responses to Liberty's tariff sheet must be filed no later than August 15, 2024.
3. This order is effective when issued.


