On July 1, 2024,<sup>1</sup> Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet assigned Tracking Number JG-2025-0003. The tariff sheet bears a September 1 effective date.

The Staff of Commission (Staff) was directed to file a recommendation no later than August 2. Staff requested an extension to August 7 due to an atypical number of rate cases currently pending before the Commission.

The Commission finds the request reasonable and will grant it. The Commission will also extend the date for other responses.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file a recommendation regarding Tracking No. JG-2025-0003 no later than August 7.

2. Any responses to Spire Missouri's application or Staff's recommendation shall be filed no later than August 13.
