Please find attached, in electronic form, the following revised tariff sheets regarding Liberty's MEEIA Cycle 1 plan and the customer charge under the Demand-Side Investment Mechanism ("DSIM"):

PSC Mo No. 6	Section 4	5 <sup>th</sup> Revised Sheet No. 21f; and
PSC Mo No. 6	Section 4	4 <sup>th</sup> Revised Sheet No. 27e.

These sheets bear an issue date of August 2, 2024, and a requested effective date of October 1, 2024 (60 days after filing).

Revised sheet 21f trues up the DSIM rate to adjust for over-recovery in the past year (the first year of Liberty's DSIM). Liberty proposes to revise sheet 27e to modify the Residential Heating, Ventilation, and Air Conditioning ("HVAC") Rebate. This will align Liberty's DSIM true-up process with the other electric IOUs. Redlined tariff sheets and workpapers are being provided to all parties, and the Direct Testimony of Kim Dragoo is being filed herein to explain all proposed changes.
