## ORDER DIRECTING NOTICE AND STAFF RECOMMENDATION AND SETTING INTERVENTION AND RESPONSES DEADLINES

On July 31, 2024, in File No. ER-2025-0039, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) submitted direct testimony and a revised tariff sheet designed to implement an adjustment to its Fuel and Purchased Power Adjustment Clause (FAC). This FAC tariff filing includes costs from January through June of 2024. This filing consists of actual fuel and purchased power costs, net of off-system sales revenues, incurred by Evergy Metro. The proposed revised FAC tariff sheet has been assigned Tracking No. JE-2025-0011 and bears an effective date of October 1, 2024.

Evergy Metro also submitted an application, in File No. EO-2025-0038, containing its true-up filing for its FAC.

Commission Rule 20 CSR 4240-20.090 provides a 60-day timeline for resolution of these rate adjustment mechanism proceedings. The Commission will direct notice be given and set a deadline for intervention applications. The Commission will also direct Staff to file recommendations in both cases and set a deadline for responses from the

Office of the Public Counsel and other parties to the proposed fuel adjustment rate and/or proposed true-up amount.

Commission Rule 20 CSR 4240-20.090(17) provides that parties to the rate case in which the Commission continued Evergy Metro's fuel adjustment clause are automatically parties to this tariff case, without the necessity of having to apply for intervention. Therefore, the Commission acknowledges that the parties to File No. ER-2022-0129 are parties to this case, and it will direct its Data Center to add those parties to the service list.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall add the parties to File No. ER-2022-0129 to the service list for these cases and shall provide those parties with a copy of this order.

2. The Commission's Data Center shall provide notice of this order to the county commissions for each county in Evergy Metro's Missouri service territory.

3. Applications for intervention shall be filed no later than August 16, 2024. Any such filing shall be submitted through the Commission's electronic filing and information system (EFIS) or delivered to: Secretary, Missouri Public Service Commission, P.O. Box 360, Jefferson City, MO 65102-0360.

4. Staff shall file recommendations regarding its examination and analysis of Evergy Metro's application and proposed tariff sheet no later than September 9, 2024.

5. Any responses by the Office of the Public Counsel or other parties to the application, tariff sheet, and/or Staff recommendations shall be filed no later than September 13, 2024.

6. This order shall be effective when issued.
