On July 30, 2024,¹ Ameren Missouri filed a Motion to Amend Order Setting Procedural Schedule and Delegating Authority requesting that the virtual local public hearing scheduled on August 22 be rescheduled to allow additional time to notify customers. On July 31, the Commission issued an order scheduling a virtual local public hearing to be held on September 20, but did not cancel the August 22 virtual local public hearing.

Accordingly, the Commission will cancel the local public hearing scheduled on August 22, 2024.

THE COMMISSION ORDERS THAT:

1. The virtual local public hearing scheduled on August 22, 2024 is canceled.
2. This order shall become effective when issued.


