ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES

On May 31, 2024, Union Electric Company d/b/a Ameren Missouri filed an application requesting authority to issue and sell additional long-term indebtedness. In addition, Ameren Missouri requested waiver of the Commission's 60-day notice requirement¹ and expedited treatment.²

The Commission will direct its Staff to file an expedited recommendation regarding Ameren Missouri's application. The Commission will also set a deadline for responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than September 3, 2024, Staff shall file a recommendation regarding Ameren Missouri's application.
2. Responses to Staff's recommendation shall be filed no later than September 6, 2024.
3. This order shall be effective when issued.
