STAFF RECOMMENDATION

Comes now the Staff of the Missouri Public Service Commission (Staff) in response to the June 10, 2009 Order Approving Non-Unanimous Stipulations and Agreements and Authorizing Tariff Filing (Order), of the Missouri Public Service Commission (Commission), authorizing Kansas City Power & Light Company (KCPL) to file tariffs with an effective date of September 1, 2009, in compliance with the terms of the Non-Unanimous Stipulation and Agreement and the Non-Unanimous Stipulation and Agreement Regarding Pensions and Other Post Employment Benefits filed on April 24, 2009 in Case No. ER-2009-0089.

On July 8, 2009, the Commission issued an Order Directing Staff to File a Recommendation and Setting Deadline for Responses in which the Commission directed the Staff to file a recommendation by July 15, 2009 respecting KCPL's July 8, 2009 filing of tariff sheets in Case No. ER-2009-0089. On July 10, 2009 the Staff filed a Motion to Expand Time for Filing of Staff's Recommendation, requesting until July 22, 2009 for the filing of the Staff's Recommendation respecting KCPL's tariff sheets in Case No. ER-2009-0089. On July 13, 2009, the Commission issued an Order Granting Motion for Extension of Time authorizing the Staff's request for an extension of time for the filing of the Staff's Recommendation.

Attached hereto as Appendix A is the Staff Recommendation of James C. Watkins, including affidavit, that the Commission should issue an Order approving the tariff sheets

identified in the Staff Recommendation, as filed on July 8, 2009 in Case No. ER-2009-0089, to become effective on September 1, 2009.

Wherefore the Staff hereby files the Staff Recommendation attached as Appendix A that the Commission should approve the Kansas City Power & Light Company tariff sheets filed on July 8, 2009, in Case No. ER-2009-0089, with an effective date of September 1, 2009.

SUBJECT: Staff Recommendation for **Approval** of Tariff Sheets Filed to Comply with the Commission's June 10, 2009 Order Approving Non-Unanimous Stipulations and Agreements and Authorizing Tariff Filing.

DATE: July 22, 2009

On July 8, 2009, Kansas City Power & Light Company (KCP&L) filed with the Commission forty seven (47) rate tariff sheets (JE-2010-0014) and one (1) rules tariff sheet (JE-2010-0015) with an issue date of July 8, 2009, and a proposed effective date of September 1, 2009. These tariff sheets are designed to comply with Ordered Paragraphs 5 and 6 of the Commission's June 10, 2009 Order Approving Non-Unanimous Stipulations and Agreements and Authorizing Tariff Filing (Order). Ordered Paragraphs 1, 5 and 6 of the Order state:

1. The Non-Unanimous Stipulation and Agreement filed on April 24, 2009, is hereby approved as the resolution of all factual issues encompassed within that Agreement in case number ER-2009-0089. . . .

5. Kansas City Power & Light Company is authorized to file tariffs in compliance with the terms of the Non-Unanimous Stipulation and Agreement.

6. Tariffs filed in accordance with Ordered Paragraph #5 shall be filed with an effective date of September 1, 2009.

The Staff has reviewed the filed tariff sheets, and is of the opinion that they are in compliance with the Commission's Order. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on July 8, 2009, to become effective on September 1, 2009 as requested by KCP&L and agreed to by the signatory parties in the Non-Unanimous Stipulation and Agreement:


