JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

COME NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”), Staff of the Missouri Public Service Commission (“Staff” and “Commission,” respectively), the Office of Public Counsel (“OPC”), Renew Missouri Advocates d/b/a Renew Missouri (“Renew Missouri”), and Consumers Council of Missouri (“Consumers Council”), collectively, the "Parties," and jointly propose to amend the procedural schedule to allow for more time to pursue a settlement for approval by the Missouri Public Service Commission ("Commission").

1. On July 24, 2024, the Commission issued an order establishing a procedural schedule which allowed for a settlement conference on August 5, 2024, and surrebuttal testimony or responses to Staff's recommendation to be filed on August 15, 2024. The Parties conducted a settlement conference on August 5, 2024, and determined it would be beneficial to allow for additional time to conduct follow-up discussions from the August 5, 2024, settlement conference.

2. Since the hearings are scheduled for the end of October, the remainder of the schedule can remain in place and no party will be prejudiced. The Parties respectfully request the Commission extend the date for surrebuttal or responses to Staff's recommendation to August 29, 2024, along with the discovery cutoff as shown below:
