**ORDER EXTENDING TIME TO FILE SURREBUTTAL TESTIMONY**

The modified procedural schedule for these cases required the filing of surrebuttal testimony no later than August 12, 2024. On August 9, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) filed a pleading on behalf of itself, the Commission’s Staff (Staff), and the Office of the Public Counsel (Public Counsel). Evergy states that it met with Staff and Public Counsel to discuss possible settlement of these cases. Evergy, Staff, and Public Counsel ask the Commission to extend the due date for surrebuttal testimony by one week to allow for further settlement discussions.

The motion represents that Renew Missouri and Midwest Energy Consumers group do not object. Therefore, the Commission will extend the due date for the filing of surrebuttal testimony.

**THE COMMISSION ORDERS THAT:**

1. The *Joint Motion for Extension of the Date for Filing Surrebuttal Testimony* is granted. Surrebuttal testimony is now due no later than August 19, 2024.
2. This order shall be effective when issued.
