**ORDER MODIFYING PROCEDURAL SCHEDULE FOR
CONSIDERATION OF INTERIM RATE TARIFF**

On October 7, 2009, the Commission established a procedural schedule for consideration of Union Electric Company, d/b/a AmerenUE's request for an interim rate increase of 1.67 percent, subject to refund, as an accompaniment to its general rate increase request. That procedural schedule establishes dates for interested parties to prefile direct, rebuttal, and surrebuttal testimony, and schedules an evidentiary hearing for December 7, 2009. The procedural schedule does not, however, require the parties to file a list of issues and a statement of their positions on those issues. The Commission will modify the procedural schedule to include those additional filings.

The parties shall agree upon and Staff shall file a list of the issues to be heard, the witnesses to appear at the hearing, the order in which the witnesses will be called, and the order of cross-examination for each witness. The list of issues should be detailed enough to inform the Commission of each issue that must be resolved. The Commission will view any issue not contained in this list of issues as uncontested and not requiring resolution by the Commission. If the parties are unable to agree upon a list of issues, then the interested parties shall file separate lists of issues to be brought before the Commission. Thereafter,

each party shall file a simple and concise statement summarizing its position on each disputed issue. Parties shall in their statements of position and post-hearing briefs address the proper legal standards the Commission should use in evaluating AmerenUE's interim rate increase tariff.

THE COMMISSION ORDERS THAT:

1. The remaining procedural schedule for consideration of AmerenUE's interim rate increase tariff is modified to require as follows:

- Rebuttal testimony filed by all parties - November 17, 2009**
- Surrebuttal testimony filed by all parties - November 24, 2009**
- List of Issues, Order of Witnesses, Order of Cross-Examination, Order of Opening - December 1, 2009**
- Statements of Position - December 3, 2009**
- Hearing - December 7, 2009, beginning at 8:30 a.m.**
- Post Hearing Briefs - December 21, 2009**

2. This order shall become effective immediately upon issuance.
