ORDER CANCELING DISCOVERY CONFERENCE

On July 24, 2024, the Commission issued its *Order Setting Procedural Schedule and Delegating Authority*. The order set a Discovery Conference for August 15, 2024. The order also requires that any party that has a discovery concern file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference.

No party has filed a statement identifying any discovery concerns and the scheduled discovery conference is less than two business days away. Thus, the discovery conference is canceled.

THE COMMISSION ORDERS THAT:

1. The August 15, 2024, discovery conference is canceled.
2. This order is effective when issued.
