## **ORDER ACCEPTING STIPULATION OF FACTS, REVISING BRIEFING SCHEDULE, AND FURTHER SUSPENDING TRUE-UP TIMELINE**

Effective Date: March 10, 2011

On December 1, 2010, Union Electric Company, d/b/a Ameren Missouri, filed an application to implement the true-up of the first Recovery Period under its fuel adjustment clause. Staff filed a recommendation regarding that application on December 30, in which it advises the Commission to reject the true-up adjustment proposed by Ameren Missouri and to impose an adjustment calculated by Staff. On January 24, the Commission extended the decision-making timeline until May 29, 2011, as it is allowed to do by Commission Rule 4 CSR 240-20.090(5)(D).

On February 7, 2011, the Commission adopted a procedural schedule proposed by the parties that required them to file a joint stipulation of facts by February 18. That procedural schedule also established dates for the parties to file briefs after they filed the stipulation of facts. The parties did not file the joint stipulation of facts until March 3, and at the same time filed a joint motion asking the Commission to allow more time to file briefs and to extend the suspension of the true-up decision-making timeline by an additional month to recognize the additional time allowed for the filing of the joint stipulation of facts and the briefs.

The Commission will accept the joint stipulation of facts submitted by the parties, will modify the briefing schedule as they suggest, and will extend the true-up decision-making timeline as they recommend.

**THE COMMISSION ORDERS THAT:**

1. Pursuant to Commission Rule 4 CSR 240-20.090(5)(D), the timeline of the true-up is suspended an additional period from May 29, 2011, until June 30, 2011.

2. The Stipulation of Facts jointly filed by the parties on March 3, 2011, is accepted.

3. The following revised briefing schedule is established:
