On August 12, 2024, Spire Missouri Inc. (Spire) submitted an application requesting financing authority in the amount of \$850 million through December 2027, subject to the same conditions approved by the Commission in File No. GF-2022-0169. In addition, Spire requested waiver of the Commission's 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct its Staff to file a recommendation regarding Spire's application.

THE COMMISSION ORDERS THAT:

1. No later than September 27, 2024, Staff shall file a recommendation regarding Spire's application, or a request for an extension of time.
2. This order shall be effective when issued.
