Beginning at the intersection of a line running Korth and South, being 20' West of and parallel to the West Line of West street and a line running East and West, being 20' North of and parallel to the North Line of Southwest Old North Road; thence East, along said line, to its projected intersection with a line 20' East of and parallel to the East line of Southwest State Route JJ, (aka, Dekalb Road); thence South, along said parallel line to its intersection with the Southeasterly projection of a line 20' Southwest of and parallel to Southwest State Highway JJ; thence Northwest, along said parallel line to its intersection with the East projection of a line 20' South of and parallel to the South line of Southwest State Highway HH; thence West, along said parallel line, to its intersection with the South projection of a line 20' West of and parallel to the West Line of Main Street; thence North, along said parallel line to a point on the West projection of the center line of Main Street, being also a point on a tract of land being now or formerly owned by De Kalb Middle and High School; thence West, along said center line to the intersection with a line 20' West of and parallel to the East line of said De Kalb Middle and Highschool; thence North along said parallel line to a point in the North line of said De Kalb tract; thence East, along said North line to its intersection with the South projection of a line 20' West Street; thence North, along said parallel line and its North projection to the POINT OF BEGINNING.
