JOINT MOTION FOR EXTENSION OF DATE FOR FILING OF SURREBUTTAL TESTIMONY

Monday, August 19, 2024, to Tuesday, August 20, 2024. The remainder of the procedural schedule established by the Commission, including hearing dates, will remain unchanged.

4. In the event that settlement discussions are productive, the parties may seek further changes in the procedural schedule at a later date.

5. Intervenors Renew Missouri Advocates d/b/a Renew Missouri and Midwest Energy Consumers Group have indicated that they do not object to this Motion.

WHEREFORE, the Company, on behalf of itself, the Staff, and OPC, respectfully requests that the Commission extend the date for filing Surrebuttal Testimony from August 19, 2024 to August 20, 2024, as described herein.
