**JOINT MOTION FOR EXTENSION OF
DATES FOR FILING OF LIST OF ISSUES AND POSITION STATEMENTS**

COMES NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“Evergy Missouri Metro”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) (collectively, the “Company”), the Staff (“Staff”) for the Missouri Public Service Commission (“Commission”) and the Office of the Public Counsel (“OPC”) (collectively the “Signatories”), and respectfully request an extension of the dates for filing the list of issues and position statements in this case (“Motion”).

In support of this Motion, the Signatories state as follows:

1. The Signatories had previously been granted two extensions to file surrebuttal testimony in this matter in order to facilitate settlement talks.
2. Surrebuttal testimony was filed on August 20, 2024.
3. The procedural schedule ordered in this docket contemplates the filing of the list of issues today, August 21, 2024, and the filing of position statements on Monday, August 26, 2024.
4. In order to provide the Signatories time to finalize the list of issues and position statements, the Signatories respectfully request that the Commission extend the date for filing the list of issues by two days, to Friday, August 23, 2024. The Signatories also respectfully request that the Commission extend the date for the filing of position statements by one day,

to Tuesday, August 27, 2024. The remainder of the procedural schedule established by the Commission, including hearing dates, will remain unchanged.

5. Intervenor Renew Missouri Advocates d/b/a Renew Missouri and Midwest Energy Consumers Group have indicated that they do not object to this Motion.

WHEREFORE, Staff, on behalf of itself, the Company, and OPC, respectfully requests that the Commission extend the date for filing the list of issues from August 21, 2024 to August 23, 2024, and the date for filing position statements from August 26, 2024 to August 27, 2024, as described herein.
