**ORDER EXTENDING TIME TO FILE AN ISSUES LIST AND  
POSITION STATEMENTS**

The modified procedural schedule for these cases required the filing of a list of issues for the Commission’s determination no later than August 21, 2024, and position statements to be filed no later than August 26, 2024.

On August 21, 2024, The Commission’s Staff filed a pleading on behalf of itself, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West, and the Office of the Public Counsel. The motion requests that the Commission extend the deadline for a list of issues to Friday, August 23, 2024, and the deadline for party position statements to August 27, 2024.

The motion represents that Renew Missouri and Midwest Energy Consumers group do not object. Therefore, the Commission will extend the deadlines for the filing of a list of issues and position statements. Given the proximity to the start of the evidentiary hearing, it

is unlikely that the Commission will grant further extensions because this hearing cannot be moved.

**THE COMMISSION ORDERS THAT:**

1. The Joint Motion for Extension of Dates for Filing of List of Issues and Position Statements is granted. The list of issues for the Commission's determination must be filed no later than August 23, 2024, and position statements must be filed no later than August 27, 2024.
2. This order shall be effective when issued.
