**NOTICE OF DEFICIENCY**

Issue Date: August 22, 2024

On August 21, 2024, Brett Felber filed *Subpoenas, Subpoena Issued to Ameren Missouri, and Corrected Information for Subpoena Issued to Ameren Missouri*<sup>1</sup> requesting various documents and one appearance of Ameren Missouri.

Commission Rule 20 CSR 4240-2.100(1), specifically addressing subpoena requests filed at the Commission, states:

... A request for a subpoena *duces tecum* shall specify the particular document or record to be produced and shall state the reasons why the production is believed to be material and relevant.

The basis for this Commission Rule is found in Sections 386.410.<sup>2</sup> Section 386.410 requires all hearings before the commission to be governed by rules adopted and prescribed by the commission.

2. All statutory citations refer to RSMo 2016 unless otherwise noted.

The subpoena requests filed specified documents sought by the filer, but did not state the reasons why the production is believed to be material or relevant. The subpoena requests are deficient and the Commission shall take no further action regarding them until such time as the deficiency is corrected.
