REVISED MOTION CONCERNING LOCAL PUBLIC HEARINGS

COMES NOW Missouri-American Water Company ("MAWC"), by and through counsel, and, on behalf of itself and the Staff ("Staff") of the Missouri Public Service Commission ("Commission"); Office of the Public Counsel; Consumers Council of Missouri; AARP; Midwest Energy Consumers Group; City of St. Joseph; City of Riverside; Public Water Supply Districts No. 1 and 2 of Andrew County; and The Empire District Electric Company d/b/a Liberty, 1 states as follows to the Commission as their *Revised Motion Concerning Local Public Hearings*:

1. On August 7, 2024, the Commission issued an *Order Setting Procedural Schedule*, which included that local public hearings in this case would begin October 28 and end November 8, 2024 (excluding October 30-November 1)². The Order further directed as follows:

The parties are directed to work with the presiding judge to identify dates for local public hearings to take place within the above-listed time frame. No later than August 21, 2024, Staff shall file a proposal for local public hearing dates and locations on behalf of all joining parties.

2. On August 15, 2024, MAWC, on behalf of most parties, filed a *Motion Concerning Local Public Hearings*. Subsequently, on August 20, 2024, the Regulatory Law Judge contracted the parties and asked that they revise their proposed local public hearing schedule after taking into account certain Commission issues and concerns.

¹ Neither Missouri Industrial Energy Consumers, nor Triumph Foods, LLC, have responded to communications regarding this Revised Motion. Thus, they have neither indicated their willingness to join, nor stated any opposition to, the Revised Motion.

² The proposed schedule also seeks to avoid having local public hearings on November 5, 2024, General Election Day.

3. In light of the RLJ's communications, the parties have revised their potential dates, times and locations for such local public hearings and now propose the following:
