On August 14, 2024, Co-Mo Comm, Inc. d/b/a Co-Mo Connect applied to expand its designation as an Eligible Telecommunications Carrier (ETC) in order to participate in the Missouri Universal Service Fund (MoUSF), including the Missouri Lifeline subsidies, in all areas where Co-Mo Connect currently holds ETC designation.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and will direct the filing of a recommendation by the Staff of the Commission (Staff).

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all eligible telecommunications carriers certificated to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than September 6, 2024. Such applications shall be filed with:
