**ORDER DIRECTING NOTICE, SETTING AN INTERVENTION
DEADLINE, AND DIRECTING STAFF TO FILE A PLEADING**

On August 26, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application with the Missouri Public Service Commission, requesting that the Commission grant it a Certificate of Convenience and Necessity to acquire all, or substantially all, of the water system assets of the currently regulated system of Gascony Water Company, Inc., in Gasconade County, Missouri. The application also requests a variance of the 60-day notice requirement contained in Commission Rule 20 CSR 4240-4.017(1).

The Commission will direct that notice be given, set a deadline for intervention requests, and order its Staff to file a pleading.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall provide a copy of this order to the County Commission of Gasconade County, Missouri, and the General Counsel for the Missouri Department of Natural Resources.

2. The Commission’s Public Policy and Outreach Department shall make notice of this order available to the media serving Gasconade County, Missouri.

3. Any application to intervene shall be filed no later than September 26, 2024.
4. No later than September 10, 2024, the Commission's Staff shall file a pleading indicating when it can file a recommendation about Confluence Rivers' application.
5. This order shall be effective when issued.

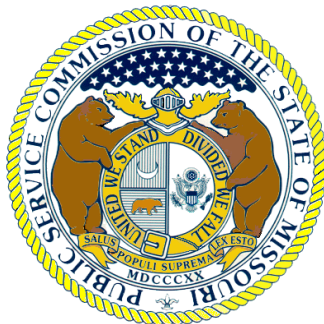
