ORDER DIRECTING EVERGY TO FILE WORKPAPERS

The Commission is directing Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) to file workpapers containing the individual annual budgets, annual total MWh savings and annual total MW savings for each subset program in each of Evergy’s residential and commercial programs in its original MEEIA 4 filing as referenced by Staff witness Mark Kiesling in his surrebuttal testimony on page 6.

Evergy shall confirm with Staff the specific workpapers it relied on for its testimony.

The workpapers shall be filed in an Excel format with all formulas intact.

THE COMMISSION ORDERS THAT:

1. Evergy shall file the workpapers described in the body of this order no later than the close of business on August 29, 2024.

2. This order is effective when issued.
