On July 26, 2024, Spire Missouri Inc. d/b/a Spire applied for an accounting authority order relating to certain of its interest rate hedging positions. On August 27, 2024, Spire and the Staff of the Commission, filed a *Full and Unanimous Stipulation and Agreement*. The agreement stated that the Office of the Public Counsel had been informed of the agreement and did not object; however, Public Counsel did not sign the agreement. Commission Rule 20 CSR 4240-2.115(2)(B)-(C) states that parties have seven days after the filing of a nonunanimous stipulation and agreement to file objections. Failure to file a timely objection constitutes a waiver of that party's right to a hearing and the agreement may be treated as unanimous. The time for objections is set out below.

THE COMMISSION ORDERS THAT:

- 1. Any objection to the *Full and Unanimous Stipulation and Agreement* shall be filed no later than September 3, 2024.
 - 2. This order shall be effective when issued.
