On August 29, 2024, Spire Missouri Inc. d/b/a Spire filed a status report which included a request to be ordered to file a status report or settlement agreement no later than September 30, 2024. Spire indicated the agreement of the Staff of the Commission and the City of Kansas City to the request. Spire indicated that the parties have circulated a draft of a settlement agreement and require additional time to finalize it.

The Commission finds the request reasonable and will grant it.

1. The parties shall file a status report, a settlement agreement, or a request for an extension of time no later than September 30, 2024.
