## **REQUEST FOR ADDITIONAL TIME**

**COMES NOW** Spire Missouri Inc. ("Spire Missouri" or the "Company") and respectfully submits this *Request for Additional Time* to the Missouri Public Service Commission ("Commission"), stating the following:

- 1. On April 16, 2024, Staff of the Commission ("Staff") filed a Formal Complaint as a follow-up to its investigation in Docket No. GS-2022-0261.
- 2. On April 23, 2024, the Commission directed Spire Missouri to file an answer to the Formal Complaint no later than May 23, 2024.
- 3. Spire Missouri has requested extensions to file its answer in order to allow the Company and Staff to reach a resolution in this case. The current deadline for its answer or a status update is August 30, 2024.
- 4. Spire Missouri is committed to providing a plan to meet Staff's recommendations in the first week of September. Additional time will be required for Staff to review the plan and provide feedback, and for further discussions between the parties. Therefore, the Company requests the Commission extend the time for the Company to file its answer or a status update until September 30, 2024. Staff has been notified of the request and does not object.

**WHEREFORE**, Spire Missouri respectfully requests that the Commission direct the Company to file its answer or a status update no later than September 30, 2024, and order any other relief as is just and reasonable.
