On August 2, 2024, The Empire District Electric Company d/b/a Liberty filed supporting testimony and tariff sheets to true-up its demand-side investment mechanism rate to adjust for an over-recovery during the first year of Liberty's Missouri Energy Efficiency Investment Act Cycle 1. Those tariff sheets bear an effective date of October 1, 2024.

The Commission will issue notice, set an intervention deadline, and direct its Staff to file a recommendation. The Commission will also set a deadline for any responses to Liberty's tariff sheets.

THE COMMISSION ORDERS THAT:

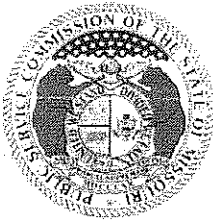
1. The Commission's Data Center shall serve a copy of this order upon the parties to File No. EO-2022-0078.

4. Staff must file a recommendation about Liberty's tariff sheets no later than August 30, 2024.

5. Any other responses to Liberty's tariff sheets must be filed no later than August 30, 2024.




