MOTION TO CORRECT ORDER NUNC PRO TUNC

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), and for its *Motion to Correct Order Nunc Pro Tunc* respectfully states to the Missouri Public Service Commission ("Commission") as follows:

- 1. On April 3, 2024, the Commission issued its *Order Establishing Ending ACA Balance* ("*Order*"). The *Order* stated that Ameren Missouri's ACA filing in this matter "...was made to reconcile actual gas costs with revenue recoveries for the period of September 1, 2021 through August 31, 2022."
- 2. The *Order* also states that Staff filed a reply in this case that ultimately recommended the Commission "... accept Ameren Missouri's ending ACA balances as filed by Ameren Missouri. ... Accordingly, without Staff's adjustments, Ameren Missouri's ACA ending balances as of August 31, 2022, are \$34,795,463.66 for Firm Sales and \$379,724.01 for Interruptible Sales."
- 3. However, the *Order's* last paragraph on page 2, and ordered paragraph 1 on page 3, mistakenly state the **2020-2021** ACA audit and **2020-2021** Actual Cost Adjustment, respectively.
- 4. Additionally, ordered paragraph 2 on page 3 mistakenly states "Staff Recommended ACA Balance 8/31/21."

- 5. References to 2020-2021 should be corrected to read 2021-2022. The reference to 8/31/21 should be corrected to read 8/31/22.
 - 6. This motion is being filed as soon as possible after identifying the clerical errors.
- 7. The Commission can correct its own orders *nunc pro tunc*. The corrections are non-substantive and correct clerical errors discernible from the pleadings.

WHEREFORE, Ameren Missouri requests the Commission correct its *Order Establishing Ending ACA Balance* as set out in paragraph 5 above.
