ORDER CANCELING EVIDENTIARY HEARING

On August 30, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West's filed a motion on behalf of itself, the Staff of the Commission, and the Office of the Public Counsel to suspend the procedural schedule and cancel the evidentiary hearing set for September 3, 2024.

The motion states that the parties have reached an agreement in principle and ask for time to submit a stipulation and agreement resolving all the issues in this case. The motion asks that the Commission allow the parties until September 6, 2024, to file a stipulation and agreement or a status report. The motion represents that the intervenors in this matter do not object.

The Commission will cancel the evidentiary hearing currently set for September 3-9, 2024.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing scheduled for September 3-9, 2024, is canceled.

2. The parties shall file a stipulation and agreement or a status report no later than September 6, 2024.

3. This order is effective when issued.
