On August 20, 2024, Union Electric Company d/b/a Ameren Missouri withdrew its tariff, Tracking No. JE-2024-0131.

Commission Rule 20 CSR 4240-2.116(1) states that a party may dismiss an application without an order of the Commission before prepared testimony or oral evidence has been offered. Ameren Missouri seeks to dismiss this matter by withdrawing its tariff from consideration.
