## **NOTICE OF INTENDED CASE FILING**

1. 20 CSR 4240-20.045 contains the requirements for filing for CCNs for electrical production facilities.

2. The issues likely to be before the Missouri Public Service Commission ("Commission") in this case may be any issue related to whether the requested natural gas electrical production facilities are necessary or convenient to the public service.

3. Regarding the requirement in Rule 4.017(1) that a 60-day notice of filing include "a summary of all communications regarding substantive issues likely to be in the case between the filing party and the Office of the Commission that occurred in the ninety (90) days prior to the filing of the notice", the Company verifies that Evergy Missouri West has had no communications with the Office of the Commission (as defined in 20 CSR 4240-4.015(10)) respecting this filing during the 90 days prior to filing this notice.

4. Evergy Missouri West may seek a waiver of this Notice requirement when it files its CCN application.
