#### JOINT RESPONSE TO ORDER DIRECTING FILING

**COMES NOW** Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri"), on behalf of itself, the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), and the Office of the Public Counsel ("OPC") (collectively, "Parties"), and respectfully proposes the following Procedural Schedule in response to the Missouri Public Service Commission's Order Directing Filing:

On August 26, 2024, the Missouri Public Service Commission ("Commission") issued an order directing the Parties to propose an alternative hearing date since the hearing room was unavailable on the date the Parties suggested for the hearing.

In response to the Commission's Order, Staff and the Company request that the Commission adopt the following Procedural Schedule which not only revises the evidentiary hearing and briefing dates, but also the dates for prefiling testimony and other prehearing events. OPC joins in offering two possible hearing dates in February of 2025. OPC supports the post-evidentiary hearing briefing dates if the evidentiary hearing transcripts are expedited; if the evidentiary hearing transcripts are not expedited OPC proposes that initial briefs be due 35 days later—March 13, 2025, or March 14, 2025—and reply briefs be due 21 days later—April 3, 2025, or April 4, 2025. While OPC does not oppose modifying the pre-evidentiary hearing procedural schedule filing dates as Staff and Ameren Missouri propose, OPC does not join in requesting the Commission to modify them from what Staff, Ameren Missouri and OPC proposed on July 22, 2024.
