**ORDER GRANTING STAY OF SUBPOENAS
OR SUBPOENAS *DUCES TECUM***

Issue Date: September 5, 2024

Effective Date: September 5, 2024

On August 21, 2024, Complainant Brett Felber requested the Commission to issue subpoenas or subpoenas *duces tecum*. On August 23, 2024, the Commission issued those subpoenas or subpoenas *duces tecum* to the Complainant. On September 4, 2024, Ameren Missouri filed a Motion to Quash. Judge John Clark of the Commission filed a similar motion that same day.

Commission Rule 20 CSR 4240-2.100(3) allows “ten (10) days from the date the subpoena or subpoena *duces tecum* is served” for objections to be filed. No return of service of the subpoenas or subpoenas *duces tecum* has been filed, so the Commission is unaware of the date they were served. However, to give parties the opportunity to object or to respond to the motions to quash, the Commission will issue a stay of the subpoenas or subpoenas *duces tecum*. No party will be required to comply with Complainant’s subpoena or subpoena *duces tecum* until further order of the Commission.

THE COMMISSION ORDERS THAT:

1. No party is required to comply with Complainant's subpoena or subpoena *duces tecum* until further order of the Commission.
2. Any party who wishes to respond to the September 4, 2024 motions to quash shall do so no later than September 16, 2024.
3. Complainant shall file any return of service of subpoenas or subpoenas *duces tecum* in this file no later than September 16, 2024.
4. This order is effective when issued.
