It is apparent that the Commission is interfering with the service and subpoenas in question. The Commission has allowed Ameren Missouri and more importantly to infringe upon my rights as a Complainant. It is apparent that the Commission is participating in collusion and withholding important items and allowing Ameren Missouri to more importantly hide the documents.

The Commission knows the truth and more importantly, Ameren knows the truth. It is apparent, that Ameren Missouri would rather cycle through and hire more corrupt attorney's and further commit collusion.

I paid good money for service of the subpoenas and the requested documents. As a result, I have been now defrauded even further by the Commission out of another \$ [REDACTED] towards service of those.

I was defrauded out of \$ [REDACTED], plus the \$ [REDACTED] for the subpoenas to be served, along with property damage and other acts.

Unfortunately we have taken a different approach and discovered after talking with multiple agencies the billing can be disputed under Illinois law, as my bills generate from Chicago, Illinois to submit payment to .

Under Illinois law we have made the Attorney General's Office aware of the extortion methods that the Missouri Public Service Commission has engaged in and further Ameren has engaged and participated.

I don't know why the Commission is defending Ameren Missouri. There were open violations, perjury committed by Staff and the Regulatory Judge and the Commission in general. To the date, any items requested have been denied, period.

The Commission has made it clear, rather than offer a fair opportunity to the Complainant, they would deny the Complainant's rights and more.

I asked for fairness and return all I have gotten is fraud and further fraud.

If you are going to design a process that defrauds complainants out of money, then don't accept complaints. Period.

Ameren Missouri defrauded me out of good money, further they were able to utilize counterfeit document.

I have never seen a State agency engage in more fraud than anything. If anything, it is misleading. What is even worse it is a bunch of whining attorney's that badger to get their way or it is no way.

At no time has Ameren Missouri complied with a single DR request or DR data to be given to me in any order or fashion.

All their paperwork is on blank stock paper with no vendor software information on it. Instead it is altered with markings of their email address being www2.ameren.com

I don't give two ***** what the Commission thinks about the document. It is fraudulent, they utilized a Government portal to file false documents.

There is no statute of limitations to false filings and it reopens the matter. I have talked to several agencies about that and I can confirm.

I am taking a different option as I believe it is best. I have filed a complaint with the State of Illinois Attorney General and the Department Of Justice for apparent collusion and fraud.

Bottom line is the complaints are not going to stop until Ameren Missouri and the Commission remit payment of \$ [REDACTED] for the extortion payment and the \$ [REDACTED] for defrauding me out of service of subpoenas.

At this point we are prepared to file a police report, file suit in court and ask for the Department of Justice to investigate the

Commission and Ameren Missouri for a lengthy series of collusion and financial fraud.

Ameren Missouri and the Commission have engaged themselves in a pattern of financial fraud, computer fraud, collusion, counterfeit and forgery documents, Deceptive business practices and theft by deception.

No complaints out of the Commission or with the AG's Office will be dismissed until Ameren Missouri and the Missouri Public Service Commission remit the \$ [REDACTED] and \$ [REDACTED] for the subpoena returns of service.

We are also prepared to file a prejudgment seizure of Ameren assets as early as Monday September 10, 2024 for engaging in fraud and defrauding the Complainants.

This is a final demand and remit all monies extorted immediately upon receipt of this document through EFIS.

In addition, due to the severe fraud committed by Ameren and as they have already committed an illegal disconnection of utility service clearly, as a precaution the the complainants smart meter serial number has been entered into the imei database (IMEI D8) in which the serial number acts as a imei number and until Ameren Missouri rectifies the \$ [REDACTED], their provider and Landis Gyr will not allow Ameren Missouri functions to remotely disconnect utility service with over the air signals or provisioning until they rectify the \$ [REDACTED].

When Ameren Missouri rectifies the amount Landis Gyr and other affiliates will remove the blacklist of fraudulent activity through over the air provisioning signals.

The AG's Office is aware of that too.

Ameren also has until the end of business regardless of a Commission decision to release and send daily kilowatt hour

paperwork to me from December 2023 through September 5th, 2024 or we will seek a more permanent blacklisting option to refrain Ameren from possible illegal disconnections in the future.
