On June 26, 2024, the Commission granted Spire’s Motion to Dismiss and dismissed the complaint by order effective July 26, 2024. On July 22, 2024, the Complainant filed an Application for Rehearing. Thereafter, Complainant filed additional documents, which were not relevant to the application for rehearing.
