**ORDER DIRECTING NOTICE, SETTING AN INTERVENTION
DEADLINE, AND DIRECTING STAFF TO FILE A PLEADING**

On September 4, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application with the Commission requesting a Certificate of Convenience and Necessity (CCN) to acquire, own, install, construct, operate, control, manage and maintain sewer systems in Nodaway and Andrew Counties, Missouri. The requested CCN would allow Confluence Rivers to acquire the sewer system assets and CCNs of United Fiber’s currently regulated sewer systems. United Fiber operates nine separate sewer systems and provides sewer service to approximately 360 customers in Nodaway, and Andrew Counties, Missouri.

The Sewer Systems:

Maryville Area

- Country Side View
- Pleasant View Addition
- Scout Ridge Estates
- Highland Estates

Savannah Area

- Spring Meadows/Meadow View

St. Joseph Area

- Indian Ridge Development
- Millstone Subdivision
- Tuscany Lake/Vista/West Ridge/Bristol
- Dawn Valley

The application also requests a waiver of the 60-day notice requirement contained in Commission Rule 20 CSR 4240-4.017(1).

The Commission will direct that notice be given, set a deadline for intervention requests, and order its Staff to file a pleading.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the County Commissions of Nodaway and Andrew Counties, Missouri, and the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving Nodaway, and Andrew Counties, Missouri.
3. Any application to intervene shall be filed no later than October 4, 2024.
4. No later than September 13, 2024, the Commission's Staff shall file a pleading indicating when it can file a recommendation regarding Confluence Rivers' application.
5. This order shall be effective when issued.
