**ORDER CANCELING HEARING AND REMAINING
PROCEDURAL SCHEDULE**

On December 12, 2023, Southway Storage, LLC filed an application requesting that its electric supplier be changed from The Empire District Electric Company d/b/a Liberty to White River Valley Electric Cooperative, Inc. (White River). On April 24, 2024, the Commission set a procedural schedule, which included an evidentiary hearing and post-hearing briefing.

On September 5, 2024, Southway Storage filed a motion to stay the proceedings. The request stated that Southway Storage and Liberty have an agreement in principle and are continuing to negotiate a final resolution. Once an agreement has been finalized, Southway Storage stated it expects to file a Motion to Dismiss. The parties expect that this will occur promptly.

The request to stay the proceedings indicated the support of Liberty and the non-objection of White River and the Staff of the Commission.

The Commission finds the request reasonable and will grant it. The Commission will cancel the scheduled evidentiary hearing and the remaining procedural schedule and set a time for a status report or other filing.

THE COMMISSION ORDERS THAT:

1. The remaining procedural schedule, including the evidentiary hearing scheduled for September 12, 2024, is canceled.
2. Southway Storage shall file a status report, or other appropriate filing, no later than September 26, 2024.
3. This order shall be effective when issued.
