### ORDER SETTING A DEADLINE FOR BLEVINS TO SHOW CAUSE WHY THIS MATTER SHOULD NOT BE DISMISSED

Issue Date: September 6, 2024 Effective Date: September 6, 2024

On June 13, 2023, Leon Travis Blevins (Blevins) applied for a certificate of convenience and necessity (CCN) regarding several water systems in Pulaski County. Blevins is also a party to two other matters before the Commission – a complaint brought by the Staff of the Commission in WC-2023-0353; and a request to place Blevins' water systems in receivership in File No. WO-2024-0036.

Throughout the pendency of the complaint and receivership cases, Blevins asserted that he wanted to withdraw his application for a CCN. However, Blevins has not filed a request to dismiss his application.

Commission Rule 20 CSR 4240-2.116(4) provides that the Commission may dismiss a case for good cause found after ten days' notice to the parties. The Commission will not dismiss Blevins CCN request without giving him an opportunity to explain why his CCN request should not be dismissed. Therefore, the Commission will set a deadline for Blevins to file a pleading, if he does not want the Commission to dismiss his request for a CCN.

#### THE COMMISSION ORDERS THAT:

- 1. No later than September 16, 2024, Blevins may file any reasons that this case should not be dismissed.
  - 2. This order shall be effective when issued.
