

Affidavit Additional Information

An affidavit (or statutory declaration) is used to record a statement of facts made by an individual. An affidavit is typically used as evidence in court while statutory declarations are more commonly used when dealing with government agencies, such as providing a statement as part of obtaining an immigration visa. If you are unsure which format your statement should be in it is generally best to go with an affidavit since statutory declarations are rarely used unless specifically requested.

IMPORTANT: Your affidavit will not become valid until you sign it in front of a notary public.



Print your affidavit after reviewing your answers for mistakes and missing information.



Sign your affidavit in front of a notary public. Sign your initials next to any hand written portions BEFORE signing the final document.



File the signed and notarized affidavit with the court. Some jurisdictions require a standardized backer be attached as the last page. Contact the local clerk of the court you are filing in to ask about any backer requirements.

Affidavit Tips

- A backer exists to help court staff quickly file the document in the correct court file so it should be attached to the back facing out. It commonly consists of:
 - The style of proceedings (i.e. who is suing whom, case I.D. number, and court details);
 - Your name and the date you made the affidavit;
 - The number of the affidavit (in case you made multiples);
 - A description of the document (i.e. "affidavit"); and
 - Your contact info (i.e. name, address, phone number, and fax or email).

Generally, a backing sheet is not necessary but is considered more professional.

- You may refer to additional documents in your statement of facts and attach them as exhibits to be submitted with the rest of your affidavit.
- Copies of the affidavit are typically given to each party involved in the suit.
- Your affidavit must include only truthful statements of facts. It is a serious offence to make a false or misleading affidavit.
- Make sure to only include statements of fact that you have firsthand knowledge of. You cannot include statements that you heard from a third party (this is called hearsay).
- The best affidavits avoid vague statements and are simple, consistent, and short. This makes them easier to present and understand in court.
- Do not try to write in legalese. Clear, plain language is best. Do not include ambiguous statements (e.g. "John Smith stated that..." is better than "John Smith left me with the impression that...").

Sample Affidavit

The plaintiff's name(s) appears first. If there are multiple plaintiffs they are separated by using "and".

AFFIDAVIT

I, Brett Felber, of [REDACTED], [REDACTED], in [REDACTED], [REDACTED], MAKE OATH AND SAY THAT:

1. I, Brett Felber am creating this affidavit to be used for court purposes and for the direction of exposing a counterfeit document that Ameren Missouri published, produced, altered and manipulated.
2. I, Brett Felber & Hypercore Mobile & Network Consultants LLC are in possession of three payment agreements.

3. The first payment agreement has no watermark index, as it is the true master copy sent from Ameren Missouri and DoNotReply@ameren.com.
4. The first original and true copy with no watermark strike through it contains a payment date of May 22, 2023.
5. Hypercore Mobile & Brett Felber are the sole owners and reserve all legal rights to those documents.
6. The document was sent by Ameren Missouri and more importantly SendGrid conformation of 8:36 am on Thursday May 18, 2023 for a payment date of May 22, 2023.
7. The second copy of the payment agreement has a watermark indexed through the payment terms and agreement amounts therefore, the document can't be manipulated, altered, produced, etc.
8. Ameren Missouri is a evidentiary hearing openly admitted to altering Ameren Missouri documents.
9. The watermark preservation is a must, as Ameren Missouri admitted to altering documents, in which could manipulate the dates, times, tracking cookies, etc.
10. The second payment agreement agrees with the first. It was sent at 8:36 am on Thursday May 18, 2023. It also had a payment agreement date of May 22, 2023.
11. Both exhibit A& B attached will also included the tracking cookies, which are identified at the bottom, which authentic the document was sent from Ameren Missouri and their servers.

It to has an outbound email address of DoNotReply@ameren.com.

12. The third payment agreement, submitted by Ameren as MOPSC NO 0027, is a counterfeit , manipulated, altered and fraudulent copy produced by not only Ameren Missouri, but also Ameren Missouri's legal counsel, co-counsel and there might be some physical engagement conducted by the Missouri Public Service Commisison, in crafting this document.
13. NO MOPSC has been rant through three different counterfeit document programs in which all three document processor concluded MOPSC NO0027 is fraudulent and a counterfeit copy.

14. MOPSC0027 copy doesn't have a valid email address. Ameren imposters the email address as www2.ameren.com, which is a website hosting address.
15. MOPSC0027 copy fails to have the tracking cookies of where the origin of this agreement comes from. This concludes the document didn't send or transmit, as it failed to identify article of the cookies attached to it.
16. MOPSC0027 fails to embed an @ symbol thus the document wouldn't have sent.
17. MOPSC0027 document fails to embed the PAG terms which are also known as the monthly installment amounts, number of installments, etc.
18. MOPSC0027 document fails to embed vendor information or correspondence information .
19. MOPSC0027 doesn't have DoNotReply@ameren.com as an email address, as compared to exhibit A & B which encode that with the tracking cookies for transmission.
20. MOPSC0027 was created and transmitted via electronically to [REDACTED] from Banks Law LLC, Ameren Missouri and Aubrey Krcmar.
21. Ameren Missouri openly admitted that they failed to keep a copy of the agreement on file.
22. After extensive research and document retrieval services we can confirm MOPSC0027 was a counterfeit document as www2.ameren.com doesn't show up in ICANN Register or RDAP server.
23. Hypercore Mobile & Network Consultants can confirm the IP address utilized and the counterfeit document can be found on any Ameren Missouri Computer or Server that has the following IP address of

24. Any server with the following addresses above will be able to retrieve Ameren Missouri's counterfeit payment agreement from those name servers.

25. Hypercore Mobile & Network Consultants LLC can confirm that MOPSC0027 failed identifiers in all three detection software and was a manual input item, by Ameren Missouri.
26. Exhibit A&B in possession by Brett Felber & Hypercore Mobile & Network Consultants LLC has the true source of payment agreement from DoNOTReply@ameren.com and the tracking cookies for verification.
27. Upon further research it is concluded under severe testing that Ameren Missouri committed not only computer fraud, but Corporate fraud, privacy policy fraud, financial fraud with the intent to deceive using electronic devices. Theft by deception. Fraud, counterfeit and forgery.
28. Under Missouri law, Ameren Missouri is not entitled to a copy or master copy of the agreement and the only parties that can and will obtain them in Hypercore Mobile & Network Consultants LLC.
29. Ameren is not entitled to a copy of Exhibit A , they are entitled to a copy of exhibit B, with the watermark protection therefore they cannot manipulate the PAG terms, date of the agreement, financial amounts.
30. MOPSC0027 has a counterfeit date and forged date of May 18, 2023. However, during the investigation there is no date up top showing what time it was transmitted to [REDACTED] or what date it was transmitted on MOPSC0027.
31. MOPSC0027 concluded is fraudulent, false, counterfeit, forged, manipulated and fails to have identifiers such as tracking cookies a date and time of initiation stamped on it with the date sent, time sent, along with the fraudulent email address they've embedded.
32. Hypercore Mobile reserves the right to all protection of the actual transmitted copies of the document exhibit A&B. The true copies which contain the date and time of the email, tracking cookies, valid email address of DoNotReply@ameren.com.
33. Hypercore Mobile & Network Consultants LLC, along with Brett Felber has the sole rights to use these documents as legal tendered evidence of Level 3 fraud committed by Ameren Missouri and tendered them as evidence in any criminal or civil litigation matter commence against Ameren Missouri and more importantly the Missouri Public Service Commission.

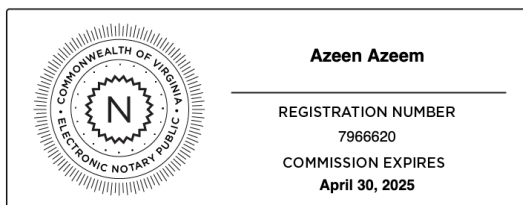

36. Lastly, Hypercore Mobile & Brett Felber reserve the right to turn over both exhibit A&B which are the true copies and MOPSC0027, which is the counterfeit to law enforcement to engage in any inquiry about the counterfeit document in question.
37. At this time concluded upon all facts, Ameren Missouri cannot be trusted with the master copy, as they will attempt to destroy it, manipulate it and alter it.
