STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets* and states as follows:

1. On August 16, 2024, Missouri-American Water Company, Inc. (“MAWC” or the “Company”) filed a tariff sheet in Tariff Tracking No. JW-2025-0019 that MAWC stated in its accompanying cover letter were being submitted pursuant to and in conformity with the *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity* that was issued on August 14, 2024.

2. The tariff sheets filed by MAWC bears an issue date of August 16, 2024, and an effective date of September 15, 2024.

3. Staff reviewed the tariff sheets filed in Tariff Tracking No. JW-2025-0019 and confirmed that the tariff sheets are consistent with the Commission’s August 14, 2024 approved *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity*.


