ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On September 9, 2024, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange telecommunications service authority and applicable tariff of Long Distance Consolidated Billing Co. ("the Company"). On January 22, 2005, the Commission granted the Company a certificate to provide intrastate interexchange telecommunications service in File No. XA-2005-0159. The Company also has an applicable tariff, Tracking No. YX-2005-0434. Staff's motion stated that the Company wishes to cancel the certificate and applicable tariff. The Company stated that it is no longer in business, has no customers in Missouri as of June 1, 2024, will not be operating in other states, and has notified all of its customers.

The Commission need not hold a hearing, if, after proper notice, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to

Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.²

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.

1. Anyone wishing to respond to Staff's Motion or to request a hearing shall do so by filing a pleading no later than September 23, 2024, with:
