On August 16, 2024, the Commission ordered the Staff of the Commission (Staff)

to file a joint proposed procedural schedule on behalf of all of the parties. Staff did so on

August 30, 2024.

The Commission has reviewed the proposed procedural schedule and will adopt it, setting an evidentiary hearing date from the three dates proposed. In addition, the

Commission will add procedural requirements to the schedule.

THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:¹

Last Day to Request Discovery	October 1
List of Issues, Exhibits, Witnesses And Order of Cross-Examination	October 22
Evidentiary Hearing	November 5
Post-Hearing Briefs (optional)	December 13

2. The hearing shall begin at 9:00 a.m. and will be conducted online via Cisco WebEx video and teleconference. The link, access telephone numbers, and access code to participate in the hearing will be emailed to all parties. Those who need additional accommodations to participate in this hearing may call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

- 3. The parties shall comply with the following procedural requirements:
 - a. Although not all parties may agree upon how each issue should be described or on whether a listed issue is in fact a proper issue in this case, the parties shall agree upon and file a list of the issues to be heard, the order in which witnesses will be called, and the order of cross-examination for each witness. The Commission will view any issue not contained in this list of issues as not requiring resolution by the Commission.
 - c. All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080.
 - d. Exhibit numbers are assigned in the following manner:

Complainants	1-99
Ameren Missouri	100-199
Commission Staff	200-299
Office of the Public Counsel	300-399

- e. Each party shall prepare a list of its pre-filed, pre-marked exhibits and file a copy of that list in the Commission's Electronic Filing and Information System (EFIS). Exhibits that may be offered during cross-examination, but which have not been pre-filed, need not be included on the list. However, when those documents are offered during the hearing, they will be assigned a number from that party's number group.
- 4. The parties shall provide a copy of all exhibits electronically to the other

parties and the Regulatory Law Judge no later than November 4, 2024.

5. This order is effective when issued.
