ORDER SETTING ADDITIONAL LOCAL PUBLIC HEARING

Issue Date: September 13, 2024 Effective Date: September 13, 2024 On September 6, 2024, Liberty Utilities (Midstates Natural Gas) d/b/a Liberty filed a request for an additional virtual local public hearing. The request was due to Liberty not providing notice of the previously scheduled local public hearings to all of its customers. Liberty acknowledged that an estimated 6,006 paperless billing customers in its Northeast Missouri and Western Missouri service areas did not receive any notification of Liberty's local public hearings.

The Commission set a time for responses to Liberty's request, but no responses were received.

The Commission finds Liberty's request reasonable and will direct an additional virtual local public hearing to be held via video and telephone conference. This virtual local public hearing does not require a computer or smart phone to attend and can be attended with a standard phone connection.

In addition to Liberty being ordered to provide notice to each of its customers, the Commission will specifically order Liberty to provide notice to all email addresses it has

associated with accounts in Northeast Missouri and Western Missouri service areas which should include at least all 6,006 paperless billing customers in those service areas.

THE COMMISSION ORDERS THAT:

- 1. Liberty's request for an additional virtual local public hearing is granted.
- 2. A virtual local public hearing is scheduled to begin at noon on Thursday,

September 26, 2024, via the video and teleconferencing service WebEx.

- a. To attend the hearing by **telephone**, at the time of the hearing call toll free 1-855-718-6621, listen to the prompt and enter the meeting number 2633 364 4186, followed by # (pound/hashtag symbol). If prompted for a password, enter 0106. If on a telephone, press the star key (*) and the number 6 to mute and unmute.
- b. To attend the hearing by **internet**, visit the website at www.webex.com or download the Cisco WebEx Meetings application. At hearing time, enter the meeting number 2633 364 4186. The password is 0106.
- 3. The Commission's Public Policy and Outreach Department shall make an

informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing. Public testimony will begin at the conclusion of the question and answer session.

4. Liberty, Staff, and OPC shall make a representative available to address substantive issues during the question-and-answer session. Any other party may also choose to have a representative present.

5. If possible, members of the public wanting to participate in the hearing should register by sending their first and last name (and whether connection will be via internet or by phone) to pscinfo@psc.mo.gov, or by calling (800) 392-4211 no later than 5:00 p.m. the day before the hearing.

6. Any person needing an accommodation to participate in the hearing should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

7. Comments may be submitted to the Commission in writing by mailing the comment to the Missouri Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102, or electronically using the Commission's electronic filing system at https://psc.mo.gov/General/Submit_Comments. When submitting comments, please reference File No. GR-2024-0106.

8. No later than ten days before the local public hearing, Liberty shall provide notice of the public hearing to each of its customers, and shall file a status report with the Commission detailing the notice, and how and when it was delivered. Such notice shall be as agreed to by the parties and set forth in Staff's *Filing of Local Public Hearing Notice*,¹ with the addition this order's meeting access information. Additionally, Liberty shall provide notice to all email addresses it has associated with accounts in its Northeast Missouri and Western Missouri service areas which should include at least all 6,006 paperless billing customers in those service areas.

9. This order shall be effective when issued.
