**ORDER GRANTING EXTENSION**

On August 30, 2024,<sup>1</sup> The Empire District Gas Company d/b/a Liberty (Empire) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet in Tracking No. JG-2025-0024.

The Staff of Commission (Staff) was directed to file a recommendation no later than September 13. On September 13, Staff filed a request for an extension to September 20 due to the filing by Empire of a substitute tariff sheet on September 12.

The Commission finds Staff’s request for an extension reasonable and will grant it. The Commission will also extend the date for other responses.

**THE COMMISSION ORDERS THAT:**

1. Staff’s request for an extension of time is granted. Staff shall file a recommendation regarding Tracking No. JG-2025-0024 no later than September 20.
2. Any responses to Empire’s application or Staff’s recommendation shall be filed no later than September 23.
