**ORDER DIRECTING STAFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On August 30, 2024 Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet in Tracking No. JG-2025-0021. Liberty projects that the changes to the WNAR tariff sheets will increase the average monthly bill of the typical residential customer in its Northeast District and West District by \$1.25 per month for each system and for its Southeast District by \$0.43 per month. The tariff sheet bears an October 1, 2024 effective date.

The Staff of the Missouri Public Service Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

THE COMMISSION ORDERS THAT:

1. No later than September 20, 2024, Staff shall file a recommendation regarding Tariff Tracking No. JG-2025-0021.

2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than September 23, 2024.

3. This order is effective when issued.
